**The Annual Town Meeting was called to order by the Moderator, Timothy Haley, at 7:00pm  
pursuant to a warrant duly posted and served**

**ARTICLE 1:** To choose all necessary Town Officers and Committees for the ensuing year.  
**Motion made to move the article as read and printed, 2<sup>nd</sup> – So Voted Unanimously**

**ARTICLE 2:** To receive and hear the reports of the Town Officers and Committees for the Fiscal Year 2014 and act in relation thereto. **Motion made to move the article as read deleting the words “and act in relation thereto,” 2<sup>nd</sup> – So Voted Unanimously** (Opal Clark reads the report for the Capital Improvement Planning Committee as printed in the Annual Town Report.)

**ARTICLE 3:** To see if the Town will set the salary and compensation of all elective Town Officers as provided by Chapter 41, Section 108 of the General Laws, and raise and appropriate a sum of money therefore, or act in relation thereto:

**ARTICLE 4:** To raise and appropriate, appropriate from available funds, or otherwise provide such sums of money as may be deemed necessary to pay the Town charges for the twelve month period commencing July 1, 2015 or act in relation thereto. **Motion made that the Town vote to Transfer \$7,697.00 from WPAT, Transfer \$13,800 from Ambulance Receipts Reserve and Raise and Appropriate \$1,816,132.00 for a total appropriation of \$1,837,629.00, 2<sup>nd</sup>.**

**Moderator asks if there is any objection to Town Accountant, Donna Couture, to speak on town meeting floor, there was no objection.** There was discussion about why a breakdown of budgets was not printed in the Annual Town Report. This discussion continued for a lengthy time and the Moderator asks if there is any objection to Town Council speaking on town meeting floor, there was no objection. **Motion made to move the question, 2<sup>nd</sup>. The Moderator declared that there was no question to move.**

**A Motion was made to change the Fire Dept. Payroll to \$72,309.00, 2<sup>nd</sup>** The Moderator asks if there is any objection to Fire Chief, Richard Stevens, speaking on Town Meeting floor, there was no objection.

**A Motion was made to set the Fire Dept. Expense Account at \$60,000, 2<sup>nd</sup> A motion is made to amend the amendment to set the Fire Dept. Expense Account at \$63,000.00 and amend the Raise & Appropriate to \$1,819,132.00, 2<sup>nd</sup>**

**Motion made to move the question, 2<sup>nd</sup> – So Voted**

**Motion as amended to set Fire Exp. At \$63,000 and to change Raise & Appropriate to \$1,819,132.00 a standing counted vote is taken Yes – 38 No – 40 Motion to amend does not pass**

**Motion made to dispense of the reading of the articles unless necessary – So Voted Unanimously**

**Motion made to act on Article No. 28 , 2<sup>nd</sup> - Moderator declares it is a majority vote – Passed Unanimously Meeting is moved to article 28 and then returned to article 5.**

**ARTICLE 5:** To see if the Town will vote, pursuant to Chapter 268A, Section 21A of the General Laws, to approve the appointment of a member of the Board of Selectmen, Board of Health, Board of Cemetery Commissioners, Board of Assessors, Finance Committee, Historical Commission, Agricultural Commission, Planning Board, Zoning Board of Appeals, and Conservation Commission as Clerk for their respective Boards, or act in relation thereto. **Motion made to move the article as written deleting the words “or act in relation thereto.” 2<sup>nd</sup> – So Voted Unanimously**

**ARTICLE 6:** To see if the Town will vote to authorize the Treasurer, with the approval of the Selectmen, to borrow in anticipation of revenue for the twelve month period beginning July 1, 2015 in accordance with 44, Section 4, of the General Laws and to renew any note or notes as may be given for a period of less than one year in accordance with the Chapter 44, Section 17, of the General Laws, or act in relation thereto. **Motion made to move the article as written deleting the words “or act in relation thereto.” 2<sup>nd</sup> – So Voted Unanimously**

**ARTICLE 7:** To see if the Town will vote to authorize the Treasurer, with the approval of the Selectmen, to borrow in anticipation of Highway reimbursement funds allotted by Massachusetts Department of Transportation Highway Division for the Fiscal Year 2016 in accordance with the provisions of Chapter 44, Section 6A of the General Laws, and Acts in amendment thereof, for a period of not more than two years from their dates of issue, or act in relation thereto.

**Motion made to move the article as written deleting the words “or act in relation thereto.” 2<sup>nd</sup> – So Voted Unanimously**

**ARTICLE 8:** To see if the Town will vote to authorize the Board of Cemetery Commissioners to utilize members of said Commission for work in the cemeteries and set their compensation at \$12.50 per hour, or act in relation thereto. **Motion made to move the article as written deleting the words “or act in relation thereto.” 2<sup>nd</sup> – So Voted Unanimously**

**ARTICLE 9:** To see if the Town will vote to authorize the Board of Health to utilize members of said Board for work at the Transfer Station, and set their compensation at \$12.50 per hour, or act in relation thereto. **Motion made to move the article as written deleting the words “or act in relation thereto.” 2<sup>nd</sup> – So Voted Unanimously**

**ARTICLE 11:** To see if the Town will vote to raise and appropriate, transfer from available funds, or otherwise provide the sum of \$5,000 into the Emergency Supplies Account, to be used to prepare for or implement relief efforts during a catastrophic event, natural disaster, pandemic, epidemic, mass immunization, or any other deemed emergency by the Board of Health, Board of Selectmen, and Emergency Management Director, said funds shall be used for, but not limited to, the purchase of supplies prior to, during and after an event, to develop action plans, update and prepare emergency shelters and facilitate planning to protect and make available resources to the inhabitants of the Town of Phillipston during said events, or act in relation thereto.

**Motion made that the Town vote to Transfer from Free Cash the sum of \$5,000 into the Emergency Supplies Account, to be used to prepare for or implement relief during a catastrophic**

**ARTICLE 12:** To see if the Town will vote to raise and appropriate or transfer from available funds, or otherwise provide the sum of \$1,546,129.00 to pay its share of the Narragansett Regional School District budget for FY 2016, or act in relation thereto.

**Motion made that the Town vote to Raise and Appropriate the sum of \$1,546,129.00 to pay its share of the Narragansett Regional School District budget for FY 2016, 2<sup>nd</sup>**

**ARTICLE 15:** To see if the Town will vote to raise and appropriate or transfer from available funds, or otherwise provide a sum of money to be used for the purpose of general repairs and maintenance on any Town owned buildings, to be expended at the discretion of the Board of Selectmen, or act in relation thereto. **Motion made that the Town vote to Raise & Appropriate the sum of \$8,000.00 to be used for the purpose of general repairs and maintenance on any Town owned buildings, to be expended at the discretion of the Board of Selectmen. 2<sup>nd</sup> – So Voted Unanimously**

**There was some discussion on the article and a motion was made to move the question – So Voted Unanimously**

**Article was voted Unanimously**

**ARTICLE 17:** To see if the Town will vote, pursuant to General Law Chapter 44B, to appropriate and transfer the sum of \$2,000 from the Community Preservation Historical Resources Reserve, for the purpose of funding the restoration of the scroll fresco located on the wall behind the pulpit in the sanctuary of the Congregational Church of Phillipston, and, to authorize the Board of Selectmen, in consultation with the Community Preservation Committee, to enter into a grant agreement with said Congregational Church for such purposes and to accept a preservation restriction or other permanent interest in said historic building, or act in relation thereto. **Motion made to move the article as written deleting the words “or act in relation thereto.” 2<sup>nd</sup> - So Voted**

**RTICLE 18:** To see if the Town will vote, pursuant to General Law Chapter 44B, to appropriate and transfer the sum of \$3,085 from the Community Preservation Historic Resources Reserve and \$7,000 from the Community Preservation Budgeted Reserve for the purpose of funding the structural restoration, completed in November, 2014, of the Historical Society Museum building located at 80 State Road, Phillipston, Assessor’s Map 33, Lot 13B, and, to authorize the Board of Selectmen, in consultation with the Community Preservation Committee, to enter into a grant agreement with the Historical Society for such purposes and to accept a preservation restriction or other permanent interest in said historic building, or act in relation thereto. **Motion made to move the article as written with the deletion of the words “or act in relation thereto.” 2<sup>nd</sup> – So Voted Unanimously**

**ARTICLE 19:** To see if the Town will vote, pursuant to General Law Chapter 44B, to appropriate and transfer the sum of \$20,000 from the Community Preservation Open Space Reserve and \$50,000 from the Community Preservation Budgeted Reserve to the Board of Selectmen, via the Parks and Recreation Department, to be used as matching funds to help to complete the Phillipston Community Park to be located on Assessor’s Map 24, Lot 2, 10.7 acres behind the Police Station, the funds used in part, for playground construction, grass, seeding, planting, benches, tables, paths as the community sees fit based on a public forum, or act in relation thereto. **Motion made to move the question as written deleting the words “or act in relation thereto.” 2<sup>nd</sup>**

**There was a lot of discussion and then a motion was made to move the question - So Voted**  
**Main motion as written – So Voted**

**ARTICLE 20:** To see if the Town will vote to hear and act on the report of the Community Preservation Committee on the Fiscal Year 2016 Community Preservation Budget and to appropriate or reserve from the Community Preservation annual revenues the amounts recommended below by the Community Preservation Committee to be expended for the purposes of committee administrative expenses, community preservation projects and other expenses in FY2016, with each line being considered a separate appropriation.

**ARTICLE 21:** To see if the Town will vote to raise and appropriate or transfer from available funds, or otherwise provide the sum of \$18,000.00 for the Assessor’s Property Update Stabilization Fund, or act in relation thereto.

**Motion made to Raise and Appropriate the sum of \$18,000.00 for the Assessor’s Property Update Stabilization Fund – So Voted Unanimously meets the 2/3<sup>rd</sup> requirement**

**ARTICLE 22:** To see if the Town will vote to transfer the sum of \$24,600.00 from the Assessor’s Property Update Stabilization Fund to the Assessor’s Triennial Recertification account to be expended for the purpose of funding the FY2016 portion of the Triennial Recertification, or act in relation thereto.

**ARTICLE 23:** To see if the Town will vote to transfer from Free Cash the sum of \$100,000 to the Capital Investment Fund, or act in relation thereto.

**Motion made that the Town vote to Raise & Appropriate the sum of \$100,000 to the Capital Investment Fund. 2<sup>nd</sup> – So Vote Unanimously**

**ARTICLE 24:** To see if the Town will vote to transfer the sum of \$50,062 from the Capital Investment Fund for the FY2016 lease payment and to authorize the Board of Selectmen to enter into a lease/purchase agreement for a period in excess of three (3) years for a tanker truck for the Fire Department and any necessary equipment therefor; or act in relation thereto.

**ARTICLE 25:** To see if the Town will vote to transfer the sum of \$42,042 from the Capital Investment Fund for the FY2016 lease payment and to authorize the Board of Selectmen to enter into a lease/purchase agreement for a period in excess of three (3) years for a 10-Wheel Dump Truck with Sander for the Highway Department and any necessary equipment therefor; or act in relation thereto.

**Motion made to see if the Town will vote to transfer the sum of \$42,042 from the Capital Investment Fund for the FY2016 payment for a 10-Wheel Dump Truck with Sander for the Highway Department – So Voted Unanimously (meets 2/3<sup>rd</sup> requirement)**

**ARTICLE 27:** To see if the Town will vote to appropriate the total sum of \$70,000 for the purpose of designing and constructing a park, to be dedicated and designated for park and recreation purposes, in perpetuity, on an approximately 9-acre portion of a 10.7-acre property owned by the Town and described as Assessors Map 24, Lot 2, said portion shown on a sketch plan, a copy of which is on file with the Town Clerk, to be subsequently divided from the remaining land containing the buildings thereon, the final boundaries of said land to be surveyed and recorded; that said land be held by the Town under the provisions of Massachusetts General Laws, Chapter 45, Section 3, and as it may hereafter be amended and other Massachusetts statutes relating to recreation, to be managed and controlled by the Phillipston Parks and Recreation Committee ; and, as funding therefor, that the sum of \$15,000 be transferred from the Parks and Recreation Reserve Account and to authorize the Treasurer, with the approval of the Board of Selectmen to borrow the sum of \$55,000 under the provisions of G.L. c.44, §8C or any other enabling authority and issue bonds and notes therefor; and, further, that the Board of Selectmen be authorized to file on behalf of the Town any and all applications deemed necessary for grants and/or reimbursements from the Commonwealth of Massachusetts and/or any others in any way connected with the scope of this Article, including the Massachusetts Landscape Partnership Program, and that the Phillipston Parks and Recreation Committee be authorized to enter into all agreements and execute any and all instruments as may be necessary on behalf of the Town to effect said design and construction, or act in relation thereto. **Motion made to move the article as written deleting the words “or act in relation thereto.” 2<sup>nd</sup> There is a review of the plan and discussion of the project and a Motion is made to move the question, 2<sup>nd</sup> – So Voted to move**

**The moderator calls for a standing counted vote Yes – 51 No - 15 (article 17 meets 2/3<sup>rd</sup> requirement)**

**Article 28:** To see if the Town will vote to raise and appropriate the total sum of \$165,000.00 (one hundred and sixty-five thousand dollars) for the purposes and as shown in the amounts below; and as funding therefor, that the Treasurer, with the approval of the Board of Selectmen, be authorized to borrow said sum and issue bonds and notes therefor pursuant to G.L. c.44, §7, or any other enabling authority; provided, however, that the amounts appropriated hereunder shall be expressly contingent upon approval by the voters of a Proposition 2 ½, so-called, debt exclusion question pursuant to G.L. c.59, §21C (k):

- a) All shrubs/trees must be kept trimmed by the lot owners to a height no higher than the headstone and approximately two feet in diameter. In the absence of a headstone, shrubs/trees must be kept trimmed to no higher than three feet tall and two feet in diameter.
- b) All plantings of any kind must be within one foot of the headstone and must be cleared of grass so it ~~does not become overgrown~~ the area does not become overgrown. For sites with markers only, temporary plants may be left in wood, metal, or clay pots; plastic and glass pots are not permitted. Pots may be placed after May 1<sup>st</sup>, but must be removed by October 15<sup>th</sup>.
- g) No fences or borders will may be erected around any lots ~~or~~ plots, or headstones without the ~~expressed~~ express written permission of the Cemetery Commission.
