"Before we begin, there was a tragic incident in Phillipston today that resulted in a loss of life for a construction worker. Our thoughts are with the family. Please join me in observing a moment of silence in his memory."

The Moderator asks Dr. Stephen Hemman to introduce our new superintendent for Narragansett starting July 1, 2016. Dr. Hemman introduces Dr. Christopher Casavant the future superintendent for NRHS School system.

The moderator asks the towns people if it is ok for Town Council, Thomas W. McEnaney to speak on Town Meeting floor. There were no objections.

ARTICLE 26: To see if the Town will vote, pursuant to General Law Chapter 44B, to appropriate and transfer the sum of \$10,000 from the Community Preservation Recreation Reserve and \$60,000 from the Community Preservation FY 2016 Budgeted Reserve to the Board of Selectmen, via the Parks and Recreation Department, for the design, purchase and installation of playground equipment, including all costs incidental or related thereto, for the Phillipston Community Park to be located on Assessor's Map 24, Lot 2, or act in relation thereto.

Motion made to move the article as printed with the deletion of the words "or act in relation thereto." 2^{nd} – So Voted Unanimously

Recommendation was given by Mark Miville, CPC, and explanation of the playground equipment.

ARTICLE 27: To see if the Town will vote, pursuant to General Law Chapter 44B, to appropriate and transfer the sum of \$10,000 from the Community Preservation Open Space Reserve and \$69,625 from the Community Preservation FY2016 Budgeted Reserve, for a total of \$79,625, to the Board of Selectmen, via the Conservation Commission, for the purpose of purchasing for conservation and passive recreation purposes, by negotiated purchase, gift, eminent domain or otherwise, a certain property together with buildings thereon, known as the Coppolino-Schlicke property, consisting of 56 acres, more or less, Assessor's Map 43, Lot 5A, that said land be conveyed to the Town of Phillipston under the provisions of Massachusetts General Laws, Chapter 40, Section 8C, and as it may hereafter be amended and other Massachusetts statutes relating to conservation, to be managed and controlled by the Conservation Commission of Phillipston; and, further, that a Conservation Restriction be placed on this property to Mount Grace Land Conservation Trust, Inc., and that the Conservation Commission be authorized to file on behalf of Phillipston any and all applications deemed necessary for grants and /or reimbursements from the Commonwealth of Massachusetts, Local Acquisitions for Natural Diversity (LAND) Grant Program, deemed necessary under Chapter 132A, Section 11 and/or any others in any way connected with the scope of this Article, and the Phillipston Board of Selectmen and the Conservation Commission be authorized to enter into all agreements and execute any and all instruments as may be necessary on behalf of the Town of Phillipston to effect said purchase, or act in relation thereto.

Motion made to move the article as printed with the deletion of the words "or act in relation thereto." 2^{nd} – So Voted Unanimously

Recommendation from CPC, Mark Miville requests the \$79,625.00 and Kevin Flynn explains the project. All were in favor.

ARTICLE 28: To see if the Town will vote to establish an Animal Control Revolving Fees Account under Massachusetts General Law Chapter 44, Section 53 E ½. This revolving fund will be credited with all licensing fees, impoundment fees, and fines received by the Animal Control Officer; and further, to authorize said receipts to be expended for the purpose of paying the Animal Control Officer salaries, supplies and kennel fees; that the Animal Control Officer be authorized to spend monies in the account; and that the limit on the total amount which may be spent from the account for the ensuing year shall be \$2,000, or act in relation thereto.

ARTICLE 29: To see if the Town will vote raise and appropriate or transfer from available funds, or otherwise provide the sum of \$7,200.00 for the purpose of purchasing new F550, with body to hold 300 gallons of water, a pump, foam system, and rescue equipment, said funds to serve as the 5% Town match required for the acceptance of the Federal Assistance to Firefighters grant from FEMA, said funds to be expended only if the Town receives said grant, or act in relation thereto.

Motion made that the Town vote to transfer from Free Cash the sum of \$7,200.00 for the purpose of purchasing new F550, with body to hold 300 gallons of water, a pump, foam system, and rescue equipment, said funds to serve as the 5% Town match required for the acceptance of the Federal Assistance to Firefighters grant from FEMA, said funds to be expended only if the Town receives said grant. 2^{nd} – So Voted Unanimously

ARTICLE 31: To see if the Town will vote to raise and appropriate, transfer from available funds or borrow \$2,395 for the purpose of paying outstanding invoices for road maintenance fees due for fiscal years 2007 through 2015 on properties located at Lot 16 and Lot 66, Secret Lake Road, which were acquired by the Town via tax taking, or act in relation thereto.
